## Agreement

We are pleased to have the opportunity to stock your book through our consignment program. Due to the economics of bookselling, it is not possible to carry every book published, and we must be especially diligent when approached to stock books outside our normal distribution chain. Our consignment program is an agreement between you, the author /consignor, and Browseabout Books, the bookseller / consignee, to offer your book for sale in our bookstore. By leaving your books with us, you agree to abide by the guidelines in this agreement.

Browseabout Books agrees to stock and sell the product described below for a term of 3 months (90 days) at which time the sales agreement will be extended or closed based on sales reports. Sales will be reviewed and payments will be made in CASH ONLY. Browseabout Books is not responsible for any books lost, stolen, or damaged while in the store.

When the sales agreement is discontinued or closed, the products will be held for 30 days. If the Consignor cannot be reached or fails to respond because of outdated contact information, the books will be donated or destroyed.

By signing this agreement, the author / consignor agrees to the following:

- Set a reasonable price for your book.
- Divide the retail price according to standard publishing industry terms: consignor receives 60% of revenue and consignee receives 40%.
- Pay for any shipping cost of the books to Browseabout Books
- Offer your books at the same retail price at all outlets and online.
- Send your friends and family to Browseabout Books to buy your book.
- Include the fact that your book is available at Browseabout Books in all of your marketing and advertising (print, online, email, & social media).
- List Browseabout Books as a purchasing option on all internet marketing materials including your website and social media.
- Browseabout Books is not responsible for any shelf wear, warpage, sun damage, browsing ware, theft or any other typical action or circumstance which may occur during the normal course of business which may result in the damage or loss of your product.
- The consignor and not Browseabout Books is solely responsible for the marketing and promotion of your product.
- Browseabout Books will facilitate author signings at the store. These events will be advertised on our website, in our store front windows, and on social media.
- This agreement may be canceled at any time by Browseabout Books for any reason.

Browseabout Books will email you when we need to replenish the books. Please do not call the store You can email authors@browseaboutbooks.com to ask about sales, replenishment, or arrange payment.
